Ringgold County Unincorporated Area Public Measure SL

Shall the following public measure be adopted?

A local sales and services tax shall be imposed (renewed) in the unincorporated area of the County of Ringgold that will continue without repeal of the existing local sales and services tax at the rate of one percent (1%) to be effective on July 1, 2027, until repealed.

Revenues from the sales and services tax are to be allocated as follows:

0% for property tax relief.

The specific purpose for which the revenues shall otherwise be expended are:

100% for maintenance of Secondary Roads, public infrastructure improvements, public safety equipment, and any other lawful purpose.

Diagonal Community School District Public Measure SM

Shall the following public measure be adopted?

Shall the Board of Directors of the Diagonal Community School District, in the Counties of Ringgold and Taylor, State of Iowa, for the purpose of purchasing and improving grounds; constructing schoolhouses or buildings and opening roads to schoolhouses or buildings; purchasing of buildings; purchase, lease or lease-purchase of technology and equipment; paying debts contracted for the erection or construction of schoolhouses or buildings, not including interest on bonds; procuring or acquisition of libraries; repairing, remodeling, reconstructing, improving, or expanding the schoolhouses or buildings and additions to existing schoolhouses; expenditures for energy conservation; renting facilities under Iowa Code Chapter 28E; purchasing transportation equipment for transporting students; lease purchase option agreements for school buildings or equipment; purchasing equipment authorized by law; or for any purpose or purposes now or hereafter authorized by law, be authorized for a period of ten (10) years, to levy annually, a voter-approved physical plant and equipment property tax not to exceed One Dollar Thirty-Four Cents (\$1.34) per One Thousand Dollars (\$1,000) of the assessed valuation of the taxable property within the school district commencing with the levy for collection in the fiscal year ending June 30, 2027, or each year thereafter?
